


Message from the Chairman





DSAP Hosts Public Forum on Ethical Entrepreneurship and Integrity in Business



Held at the SGV Hall of the AIM Conference Center last June 21, 2016, the event featured a powerhouse lineup of speakers: direct selling master Josiah Go, Atty. Minerva Sobreviga-Retanal of the National Bureau of Investigation (NBI), Jose Solomon Cortez of Integrity Initiative, Inc., and Regional Director Joel Valera of the Department of Trade and Industry (DTI).





The attendees, comprised of representatives from the DSAP member companies and the general public, had a well-spent afternoon of insights and learnings. Mr. Cortez stressed the importance of preserving a culture of integrity to achieve a level playing field in the market place to ensure consumers and producers both win. Mr. Go elucidated on the 8-Point Test in determining the legitimacy of a direct selling company or an investment opportunity. The alarming reality of proliferation of investment scams on the internet and social media was shared by Atty. Sobreviga-Retanal, who also shared the warning signs to avoid becoming a victim. Mr. Valera underpinned the value of ethical business practices and collaborative opportunities for the government and the private sector.

The forum gave the attendees opportunity to raise their questions and hear the answers and get further guidance straight from the speakers.



Themed *The Entrepreneurial Mindset*, the conference gathered a good turnout of close to 120 enthusiastic and highly engaged attendees from the DSAP member companies and the general public.

The management conference definitely did not scrimp on presenting the most noteworthy lineup of speakers that included Dean Pax Lapid, Business Consultant, Entrepreneur and Author; Ms. Mercy Evangelista, Avon Hall of Famer; Ms. Rhea Gudani/ Ryan Gudani, Nu Skin Hall of Famer; and Ms. Salve Duplito, Finance Expert and Host of ANC's On The Money.

The first speaker, Dean Lapid shared his insights that one who has the entrepreneurial mind is T.R.U.L.Y.
